**QUESTION NUMBER ONE**

On the charge of Murder, our verdict is:

**QUESTION NUMBER TWO**

On the charge of Aggravated Manslaughter, our verdict is:

- 2b. Guilty of Aggravated Manslaughter ----

**If you have found the defendant Guilty on Question Number 2b, go to Question Number Four. If you have found the defendant Not Guilty of Aggravated Manslaughter, go to Question Number Three.**

**QUESTION NUMBER THREE**

On the charge of Reckless Manslaughter, our verdict is:

- 3a. Not Guilty of Reckless Manslaughter ----
- 3b. Guilty of Reckless Manslaughter ----

**Go to Question Number Four.**

**QUESTION NUMBER FOUR**

On the charge of Robbery, our verdict is:

- 4a. Not Guilty of Robbery ----
- 4b. Guilty of Robbery ----

**If you found the defendant Guilty of Question Number 4b, go to Question Number 4c. If you find the defendant Not Guilty of Robbery on question 4a, do not go to Question Number Five.**

**(THE COURT SHOULD TAILOR AND ADD THE APPROPRIATE OPTION FOR 4c)**

**(Choose as Appropriate)**

4c. Do you find, beyond a reasonable doubt, the defendant, during the course of committing a theft from INSERT VICTIM, did purposely inflict, or attempted to inflict, serious bodily injury upon INSERT VICTIM?
