PROSECUTOR ASSOCIATION

Only a logged-in prosecuting attorney will be allowed to add or change prosecutor information on a case

Prosecutor Association – Initial assignment

- If there is not a prosecutor already assigned to the case, a prosecutor may assign themselves to the case
- From the Confirm Correct Case screen, click “Add” next to the Prosecutor name field
