ORDERED,

CASE MANAGEMENT:

1. Counsel for all parties shall meet and confer within thirty (30) days in an attempt to reach an agreement on the following issues: [Counsel is encouraged to utilize the forms and orders entered in the MDL.]

- Preliminary disclosure form
- the form and content of a Plaintiff/Defendant fact sheet
- the scope, parameters and timing for service of written discovery

Katz, U.S.D.J., Presiding Judge for the MDL. Counsel shall submit a proposed agenda 7 days prior to this Case Management Conference.

2. By consent of all parties, the court may contact or be contacted on an *ex parte* basis regarding settlement issues only.

3. The Court directs all counsel to R.1:4-8 and expects all counsel to abide by the parameters set forth therein.

4. All Court proceedings will start at the designated scheduled time. Counsel is expected to arrive promptly for these proceedings.



5. Counsel shall copy their co-counsel and all adversaries on all e-mails and other electronic correspondence submitted to the Court [COUNSEL IS PROHIBITED FROM FILING ANY PLEADING ELECTRONICALLY]. Any such submission received after 4:30 pm. will be deemed received at 9:00 a.m. on the next day Court is in session. Any such submission received after 4:30 p.m. on a Friday or over a weekend, will be deemed received on 9:00 a.m. on the next day Court is in session.

2. Designation of Plaintiffs' Lead Counsel.

By agreement of Plaintiffs' counsel, the following lawyers are hereby designated as Lead Counsel:

1. Seeger Weiss LLP. /David R. Buchanan
2. Keefe Bartels/John E. Keefe
3. Wilentz, Goldman PA./Daniel R. Lapinski

On the Court's own motion, Mr. Buchanan is designated as Liaison Lead Counsel. Lead Counsel shall be a liaison between the Court, defense counsel and all Plaintiffs counsel, shall disseminate and distribute information, notices and e-mails to all Plaintiffs' counsel, shall periodically meet with all Plaintiffs' counsel and shall prepare all agenda for case management conferences and shall interact with and coordinate with MDL counsel and the Court. Furthermore, Lead Counsel shall be responsible designating and selecting Plaintiffs' counsel to serve on any sub-committee that may be formed.
