2. Rachele Sokolis, Esq. shall, and hereby do, consent to the appointment of the Clerk of the Supreme Court as their agent upon whom service of process may be made for all actions against Rachele Sokolis, Esq. that may arise out of their participation in the matter.

3. Rachele Sokolis, Esq. shall immediately notify the Court of any matter affecting their standing with the Bar of any other jurisdiction.
